Format	Copying limits (Print and electronic)		Communicate electronically?
Literary works – Books	<ul style="list-style-type: none"> A reasonable portion may be copied (defined as 10% or one chapter, whichever is greater). For works published on the internet, 10% is the 10% of the number of words or one chapter if the work is divided into chapters. The whole work may be copied if the work is out of print or is unavailable commercially (in respect of text books, this means not able to be supplied within 6 months). 	<ul style="list-style-type: none"> Applies only to works of more than 10 pages. 	<ul style="list-style-type: none"> Yes Copyright notice Restrict access. Applies across the whole institution, so monitoring is required to ensure compliance.
Literary works – Articles (from periodicals, journals, newspapers, magazines)	<ul style="list-style-type: none"> For articles contained in a periodical publication, one article from each issue per course. Two or more articles from the same issue may be copied if they are on the same specific topic. 	<ul style="list-style-type: none"> Multiple articles copied from the same issue MUST be on the same subject. 	<ul style="list-style-type: none"> Yes Copyright notice Restrict access
Literary works – Anthologies (e.g. conference proceedings)	<ul style="list-style-type: none"> The whole of an individual work not exceeding 15 pages may be copied. More than one whole work may be copied provided the total number of pages copied does not exceed 10% of the total number of pages in the book. 	<ul style="list-style-type: none"> For print / hardcopy anthologies, the work must not have been separately published. For electronic anthologies, the work must be in a format which can be paginated (e.g. PDF). 	<ul style="list-style-type: none"> Yes, unless the work has been separately published. Copyright notice Restrict access
Dramatic works (e.g. play, film or television scripts)	<ul style="list-style-type: none"> 10% or 1 chapter, whichever is the greater. The whole work may be copied if the work is out of print or is not available commercially within a reasonable time. 		<ul style="list-style-type: none"> Yes Copyright notice Restrict access
Music (e.g. sheet music, scores)	<ul style="list-style-type: none"> 10% of the work. The whole of a musical work may be copied if it has never been published or is out of print and not commercially available within a reasonable time. 		<ul style="list-style-type: none"> Yes Copyright notice Restrict access
Artistic works (e.g. maps, pictures, graphs, charts)	<ul style="list-style-type: none"> In whole or in part if the artistic work is incidental (accompanies) the work being copied or has not been separately published. For artistic works which have been separately published, no more than a reasonable portion may be copied unless a new copy cannot be obtained within a reasonable time and at a reasonable price. For images published electronically, the whole of the image may be copied. 		<ul style="list-style-type: none"> Yes Copyright notice Restrict access
Broadcasts	<ul style="list-style-type: none"> Any broadcast from television or radio, including free-to-air, cable or satellite, may be copied in analogue or digital form, including podcasts and webcasts or programmes originally ‘born’ as free broadcasts. 		<ul style="list-style-type: none"> Yes Copyright notice Restrict access
